

A BILL FOR AN ACT

BE IT ENACTED BY THE 12TH LELU TOWN COUNCIL:


- 1. SECTION 1. Purpose: The purpose and intent of this bill is

- 3. SECTION 2. Appropriation: The sum of \$12,000.00 is hereby
- 4. authorized and appropriated to finance the procurement of

- Court Renovation Project.
- 7. SECTION 3. Apportionment: The sum appropriated in Section
- 8. 2 of this Act shall be apportioned and disbursed as
- 9. follows:
- 10. a) Consumable \$12,000.00
- 11. SECTION 4. Reimbursement: The sum appropriated in Section
- 12. 2 of this Act when available , shall be replaced into the
- 13. General Treasury.
- 14. SECTION 5. Management: The Mayor of the Lelu Town
- 15. Government shall be responsible for the management and
- 16. administration of the sum appropriated in this act that

that all purposes are used solely as apportioned and that
no obligations are incurred in excess of the appropriation
SECTION 6. Lapse Date: The sum authorized and appropriated
by this Act shall be lapsed on September $30^{\rm th}$,2022. Any
unobligated amount after the lapse date shall be
transferred back to the General Treasury of the Lelu Town
Government.
SECTION 7. Effective Date: This Act shall become an
ordinance upon the approval by the Mayor or upon its
becoming an ordinance without such signature.
