

To amend Sub-section 1.3 of Section 1 of the Lelu Town Government's Manual of Administration by changing the term of service for the Mayor.

BE IT ENACTED BY THE 11TH LELU TOWN COUNCIL:

1. **SECTION 1. Purpose and Intent:** The purpose and intent of
2. this Bill is to amend that line 2 of paragraph 1 sub-
3. section 1.3 , Section 1 of the LTG MOA be amended to read
4. as follows:
5. Section 1. Organization
6. "Sub-section 1.3. Office of the Mayor
7. The office of the Mayor is comprised of an elected person
8. serving as Mayor and few supporting staff. Mayor serves a
9. term of 4 years and is responsible for the execution of
10. ordinance and other functions established under the Charter
11. of Lelu".
12. **SECTION 2. Amendments.** To replace 3 with 4 years, as
13. amended by the Third Lelu Charter Commission.
14. **SECTION 3. Effective Date:** This Act shall become effective
15. upon signature of the Mayor or upon its approval without
16. such signature.




