BE IT ENACTED BY THE 11TH LELU TOWN COUNCIL:

- 1. SECTION 1. Purpose and Intent: The purpose and intent of
- 2. this Bill is to amend that line 2 of paragraph 1 sub-
- 3. section 1.3 , Section 1 of the LTG MOA be amended to read
- 4. as follows:
- 5. Section 1. Organization
- 6. "Sub-section 1.3. Office of the Mayor
- 7. The office of the Mayor is comprised of an elected person
- 8. serving as Mayor and few supporting staff. Mayor serves a
- 9. term of 4 years and is responsible for the execution of
- 10. ordinance and other functions established under the Charter
- 11. of Lelu".
- 12. SECTION 2. Amendments. To replace 3 with 4 years, as
- 13. amended by the Third Lelu Charter Commission.
- 14. SECTION 3. Effective Date: This Act shall become effective
- 15. upon signature of the Mayor or upon its approval without
- 16. such signature.
