BE IT ENACTED BY THE 11TH LELU TOWN COUNCIL:

- 1. SECTION 1. Purpose: The purpose and intent of this act is
- stated clearly in its title.
- 3. SECTION 2. Amendment: That section 8.5 of the LTG MOA be
- 4. amended to read as follows:
- 5. "Section 8.5: Council Duty Allowance: Duty allowance as
- 6. created by ordinance, is a form of compensation to pay for
- 7. the work performed by members of the Council outside
- 8. special and regular sessions. Official duties outside
- 9. sessions may include public meetings, committee meetings,
- 10. joint meetings, leadership meetings, investigate and
- 11. oversight duties, reporting, and COW meeting.
- 12. SECTION 3. Effective Date: This Act shall become law upon
- 13. its approval by the Mayor or upon its becoming law without
