A BILL FOR AN ACT

To amend Section 8.5 of the Lelu Town Government Manual of Administration by deleting the clause "resolution and bill drafting" and replacing "etc. with and COW meetings".

BE IT ENACTED BY THE 11TH LELU TOWN COUNCIL:

1. **SECTION 1. Purpose:** The purpose and intent of this act is
2. stated clearly in its title.
3. **SECTION 2. Amendment:** That section 8.5 of the LTG MOA be
4. amended to read as follows:
5. "Section 8.5: Council Duty Allowance: Duty allowance as
6. created by ordinance, is a form of compensation to pay for
7. the work performed by members of the Council outside
8. special and regular sessions. Official duties outside
9. sessions may include public meetings, committee meetings,
10. joint meetings, leadership meetings, investigate and
11. oversight duties, reporting, and COW meeting.
12. **SECTION 3. Effective Date:** This Act shall become law upon
13. its approval by the Mayor or upon its becoming law without
14. such approval.




