## BE IT ENACTED BY 11TH LELU TOWN COUNCIL:

- 1. SECTION 1. Purpose and Intent: The purposes and intent of
- 2. this Bill is to amend Sub-section 7.3 of the LTG MOA be
- 3. amended to read as follows:
- 4. Sub-section 7.3: Annual Vacation
- 5. For each fiscal year, each staff member who is holding
- 6. permanent employment (Treasurer & Police Officer) with LTG
- 7. is entitled for paid vacation for not more than 15 days,
- 8. irrespective of number of years in service. In case of
- 9. emergencies the Mayor or the Chairman of the Council may
- 10. re-call appropriate staffs to perform their duties.
- 11. Remaining hours shall not be transferrable from one Fiscal
- 12. Year to another.
- 13. **SECTION 2. Amendments**, inserting a new phrase "Remaining
- 14. hours shall not be transferrable from one Fiscal Year to
- 15. another.
- 16. SECTION 3. Effective Date: This Act shall become effective
- 17. upon signature of the Mayor or upon its approval without
